Eligibility requirements and rules for use of leased horses:

- A "leased" horse is any horse that is not owned by the 4-Her or his/her immediate family (parents, siblings, grandparent, legal guardian).
- The objective of a leased horse project is to allow 4-Hers who do not own a horse to learn the skills of feeding, management, care and training of horses. Through this experience they also learn the skills of decision-making, information gathering, communication, responsibility and self-confidence.
- All horses, including leased horses, must be validated in 4HOnline by May 1st of the current 4-H year.
- Horses may not be leased by multiple 4-H families at the same time.
- Exhibitors must meet all eligibility requirements as listed in the Texas 4-H Horse Show Rules and Regulations.
- The 4-H exhibitor agrees to provide the management for this horse. The term manage includes, but is not limited to, feeding, grooming, exercising, training, stall management and use of the horse.
- The 4-Her is expected to manage and care for this horse at minimum from May 1st to August 31st of the current 4-H year.
- Texas 4-H and horse show officials reserves the right to disqualify leased horses if owner and/or lessee have violated 4-H rules.
